# **MEMBERSHIP RULES**

# 1. MEMBERSHIP CATEGORY

Membership of the Association shall be for both individuals and organizations and shall comprise of the following categories.

- Honorary Fellow
- Life Member (Individual)
- Member (Individual)
- Affiliate Member (Individual)
- Young Professional Member (Individual)
- Member (Organization)
- Member (EPC Organization)
- Affiliate Member (Organization)
- Institutional Member
- Student Member

# 1.1 HONORARY FELLOW

Prominent individuals of high standing and repute, preferably from the engineering profession, may be conferred Honorary Fellowship of the Association by the Governing Council.

# 1.2 LIFE MEMBER (INDIVIDUAL)

### **Life Member (Individual)**

Member (Individual) who has been on the roll of the Association for **one year** and his/her subscription is not in arrears and is of the **age of 35 years, or above**, may opt to become a **Life Member (Individual)** after paying one-time subscription as under: -

Age of member	<u>Subscription</u>
Up to 44 years	15 times annual subscription
45 to 59 years	10 times annual subscription
60 to 69 years	5 times annual subscription
70 years and above	2 times annual subscription



# 1.3 MEMBER (INDIVIDUAL)

Every applicant for Member (Individual) of the Association shall satisfy the Governing Council that

a) he/she is a graduate in engineering from a recognized college or university or institution, or equivalent.

**AND** 

**b(1)** he/she is in the profession of Consulting Engineering, as proprietor, or as a partner, or, as a director of an engineering firm, for not less than three years.

OR

**b(2)** has been an employee in service in a responsible capacity as an Engineer in a reputed firm/firms of Consulting Engineers/Engineering firms engaged in engineering related works for a period of not less than five years.

OR

**b(3)** he/she either retired or took VRS from the engineering department and is practicing as a Consulting Engineer

OR

- **b(4)** he/she has been a Young Professional Member (Individual) continuously for ten years, in a firm of Consulting Engineers.
- **b(5)** he/she has been involved on a continuous basis with teaching an engineering subject and also engaged in providing consulting engineering services for 5 years in a recognised engineering college or university, or institution.

# 1.4 AFFILIATE MEMBER (INDIVIDUAL)

Every applicant for Affiliate Member (Individual) of the Association shall satisfy the Governing Council that:

a) He/she is a graduate in engineering from a recognized college or university or institution, and has been actively involved in the profession of Consulting Engineering for a minimum period of three years.

OR

b) he/she is a diploma holder in engineering from a recognised polytechnic or college or university or institution with seven years of service and has been actively involved in the Consulting Engineering profession/ firms engaged in engineering or technology related work in engineering applications for a minimum period of five years.

OR

c) he/she is a graduate from a recognized college or university or institution in the field of economics, management, sociology, geography, environment, law and any other field and he/she should be involved in his/ her field of expertise in engineering projects for a minimum period of three years.

OR

d) He/she is a graduate in engineering from a recognised college or university or institution and he/she is teaching in an engineering college or university or institution for more than five years.

### 1.5 YOUNG PROFESSIONAL MEMBER (INDIVIDUAL)

Every applicant for Young Professional Member (Individual) of the Association shall satisfy the Governing Council that he/she is a graduate in engineering from a recognized university or institution, and has been employed in a reputed firm of Consulting Engineers for not less than three years and is of age not more than 40 years.

# 1.6 STUDENT MEMBER

- a) Students in the Final Year of Graduation or doing post-graduation in Engineering in a recognized university or institution and are desirous of joining the consulting engineering profession. A student member shall have no voting right. A student member can continue in their category of membership for up to three years after completing their respective graduate/postgraduate courses of study.
- b) A graduate engineer from a recognized college or university or institution or equivalent having consultancy experience of less than three years.

# 1.7 MEMBER (ORGANIZATION)

Every applicant for Member (Organization) shall satisfy the Governing Council that the organization is either

a) incorporated in India

OR

(b) is an Indian owned proprietary or partnership firm which is in the practice of Consulting Engineering for not less than two years, and has an annual turnover of not less than ₹25,00,000/- (₹2.5 million) from engineering consultancy practice with at least two owners/full-time employees having a recognized engineering degree.

# 1.8 MEMBER (EPC ORGANIZATION)

Engineering, Procurement & Construction Firms incorporated in India having a minimum experience of two years a minimum annual turnover of ₹500 million, with at least two owners/full time employees having recognized engineering degree, can be admitted as Member (EPC Organization) at the discretion of the Governing Council.

# 1.9 AFFILIATE MEMBER (ORGANIZATION)

Every applicant for Affiliate Member (Organization) shall satisfy the Governing Council that the firm/organization/institution

a) subscribes to the aims and objectives of the Association

**AND** 

b) is engaged in activities relevant to the Consulting engineering profession

OR

c) is engaged in technologies such as AI and others developed for engineering applications

OR

d) firms which play a crucial role in development of solutions related to engineering aspects of built or engineered assets.
